To Municipality of North Cowichan,

BC Timber Sales (BCTS), Strait of Georgia Business Area would like to provide notification of the commencement of the review and comment period for the proposed BCTS 2023 Pacific Maritime Forest Stewardship Plan (FSP) #943, replacing the previously approved 2018 FSP. Part of the area covered under this FSP lies within the Municipality of North Cowichan boundary.

The proposed Pacific Maritime replacement FSP will cover operations of FSP signatories in the Rosewall, Little Qualicum, Millstone, Nanaimo, Chemainus, Cowichan, Koksilah, San Juan, Loss, Gordon, and Nitinat Landscape Units that are overlapped by Forest Development Units described under this Forest Stewardship Plan. The areas covered by this plan are shown in the attached overview map. These operations have been previously covered under the 2018 BCTS Pacific Maritime FSP #659 which was originally approved March 21, 2018, for a 5 year period.
