We are applying for a New Horizons for Seniors Program Grant from the Federal Government to upgrade our lounge kitchen.

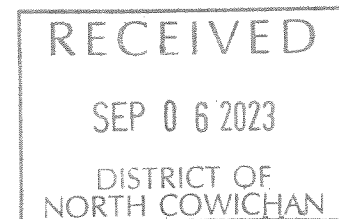
The upgrades will include:
