Permissive Tax Exemption Bylaw

BYLAW NO. 3928, 2023

A bylaw to exempt land and/or improvements from municipal taxes in 2024

WHEREAS Section 224 of the *Community Charter* permits Council, by bylaw, to exempt from taxation certain lands, improvements or both from municipal taxes;

NOW THEREFORE, the Council of The Corporation of the District of North Cowichan, in open meeting assembled, enacts as follows:

Citation

1 This Bylaw may be cited as "*Permissive Tax Exemption Bylaw No. 3928, 2023*".

Permissive Tax Exemptions

2 The following lands and improvements, used for public worship, situated within the boundaries of the Municipality and listed in Schedule "A", shall be exempt from taxation for the year 2024 pursuant to the provisions of Division 7, Section 224 [*General authority for permissive exemptions*] of the *Community Charter*.

3 The following land and/or improvements, situated within the boundaries of the Municipality and listed on Schedule "B", shall be exempt from taxation for the year 2024 pursuant to the provisions of Division 7, Section 224 [*General authority for permissive exemptions*] of the *Community Charter*.

Schedules

4 The following schedules are included in and form part of this Bylaw:
(a) Schedule "A" – Permissive Tax Exemptions – Places of Worship
(b) Schedule "B" – Permissive Tax Exemptions

Severability

5 If any section, subsection, sentence, clause or phrase of this Bylaw is, for any reason, held to be invalid by the decision of any court of competent jurisdiction, the invalid portion shall be severed and the decision that it is invalid shall not affect the validity of the remainder of this Bylaw.

Repeal

6 Permissive Tax Exemption Bylaw No. 3519 and all amendments thereto, are hereby repealed.
