Municipal Fine Amendment Bylaw

BYLAW NO. 3951

A bylaw to amend Bylaw Offence Notice Enforcement Bylaw No. 3677 and Municipal Ticket Information System Bylaw No. 3464 to include fines for obstructing Bylaw Enforcement Officers.

The Council of The Corporation of The District of North Cowichan, enacts in open meeting assembled, as follows:

Citation

1 This Bylaw may be cited as *“Municipal Fine Amendment Bylaw No. 3951, 2024”*.

Amendment

2 Bylaw Offence Notice Enforcement Bylaw No. 3677, 2021, is hereby amended by:

- (a) Striking out “Manager of Fire and Bylaw Services” under Section 6(1) and inserting “Director responsible for bylaw compliance” in its place.
- (b) Adding the following positions to Section 4 [*Bylaw Enforcement Officers*]:
 - “(5) Chief Building Inspector
 - (6) Business Licence Inspector
 - (7) Weed Control Officer”
- (c) Adding the following tables to Schedule A [*Designated Bylaws Contraventions and Penalties*]:
