4.1 Draft Master Transportation Plan - for Environmental Advisory Committee Review

David Conway, Director of Subdivision & Engineering Projects, introduced and provided background on the Master Transportation Plan. Nadine King, Watt Consulting, provided the Committee with an overview of the Master Transportation Plan process to date, addressed concerns and answered questions.

IT WAS MOVED AND SECONDED:

THAT the Environmental Advisory Committee recommend that Council direct staff to consider the following in preparation of the draft Master Transportation Plan:

- Consider wording that speaks to the flexibility in uses and expansions of rights of way; considering alternative options in cross sections and methods of acquisition.
- Add statement articulating the plan horizon and the frequency for when the plan should be updated.
- To continue to support the implementation of active transportation solutions that consider safety and accessibility issues including: separation from vehicles and path users, eco-friendly firm surface pathways, electric charging for other non-vehicle users, public end of trip facilities for cyclists.
- Increase commentary and add to maps the potential future use of the E&N railway corridor as a transportation corridor.
- Consider addition of a scenic local cross-section to acknowledge road segments that do not fit into the arterials/collector categories.
- For multi-use pathway segments, to provide consideration of pathways on both side of the roads.

4.2 Climate Change Risk and Vulnerability Assessment Project Update

Jennifer Aldcroft, Climate Change Specialist, introduced the Climate Change Risk and Vulnerability Assessment Project. Aaron Coehlo, Urban Systems Ltd, provided the Committee with an overview of the Risk and Vulnerability Assessment findings, addressed concerns and answered questions.

IT WAS MOVED AND SECONDED:

THAT the Environmental Advisory Committee recommend that Council direct staff to consider the following input in relation to the Climate Change Risk and Vulnerability Assessment Summary Report:

- The largest risks are when several climate hazards overlap. Develop actions that articulate probable scenarios for adaptation for resource allocation and continue to work with the lead agency, Emergency Management Cowichan, on disaster response.
- Assess risk of fuel and power availability from utilities and the impact on community and business continuity. Include commentary on synergies and collaborative actions to understand risk and adaptation areas.
- Articulate the gap that risks and vulnerabilities of community sectors (e.g. agriculture) were not included in taking a municipal services approach.
- Provide clarification on the scope and applicability of North Cowichan's Risk and Vulnerability Assessment and how climate hazards were considered through each risk category.

- Watershed stewardship, development needs, understanding of aquifer performance and monitoring of water (drinking and greywater) needs to be a continued area of focus.
- Consider how changing species from climate impacts is articulated.
- Include commentary on drought, coastal slides and slumping hazards. CARRIED
