#### 4.3 Verbal Update on Accessibility Action in Parks

#### 4.3.1 Presentation on Accessibility Action in Parks

Shaun Mason, Manager, Parks and Forestry Staff provided a presentation regarding the work done to date in North Cowichan's parks, as follows:

**Art Mann Park** – the new playground and the new accessible pathway are complete. The concrete platform for the new picnic table has been poured and the picnic table will be installed in the coming weeks. The playground remains closed until all work is completed.

**Kinsmen Beach Park** – work will be underway soon with an expected completion of Fall 2024.

**Sherman Road Park** - work is complete.

The Committee suggested that North Cowichan look into installing fences and gates around some of their parks to allow enhanced safety for children.

The Committee suggested that North Cowichan investigate the accessibility concerns related to the entrance and the designated parking stalls at the new RCMP building on Drinkwater Road. Neil Pukesh, Director, Parks and Recreation advised that the Parks Department will investigate the concerns and return with more information.

## **Emotional Support Animals**

Accessibility Advisory Committee August 21, 2024

### Types of Dogs

- 1. Service Dogs
- 2. Therapy Dogs
- 3. Emotional Support Animals



### Service Dogs

- Trained to perform specific tasks for a person with a disability
  - Visual, hearing, mobility impaired (ie seeing eye dogs)
  - Medical condition alerts
- Demanding multi year training
  - 30-65% of animals pass
  - ~\$25,000 training costs & 18-24 months training
- Certified training

There are two ways to be certified:

- 1. Receive a trained dog from an accredited school
- 2. Pass a public safety test



### Therapy Dogs

- Not career oriented dogs volunteers
- Family pets that work part time with organizations (ie comfort residents in nursing homes, hospitals, schools)
- Do not perform tasks no specific purpose
- Make themselves to be cuddled, petter, or spoken to.
- No certification/training requirements



### **Emotional Support Dogs/Animals**

- Provides comfort and compassion only to owner
- No formal certification/training
- A person's pet prescribed by a person's licensed specialist to be part of treatment program for emotional/psychological disability
- Person must be considered as emotionally disabled by licenced mental health therapist.



### **Animal Rights**

- Service Dogs
  - legal right to go anywhere their handler can go.
  - Equivalent of any other accessibility aid
  - Protected under BC Guide Dog and Service Dog Act
    - 1. It is a Guide Dog and Service Dog Act offence to represent a dog as a guide or service dog when it is not.
    - 2. The Guide Dog and Service Dog Act makes it an offence to deny a certified dog and handler team access or accommodation.
    - A person convicted of these offence faces a fine of up to \$3,000



### **Animal Rights**

- Therapy Dogs
  - No particular legal rights
  - Often given permission to enter businesses where animals typically aren't allowed to go (schools, hospitals, nursing homes)



### Animal Rights

- Emotional Support Dogs/Animals
  - Right to travel with owners for free
  - no other access rights to public spaces like service dogs



### Challenges

- Training certifications lack thereof
- Interpretation of service, therapy, & ESA is different
  - Definition of ESAs (dogs, cats, exotics...)
- Human sensitivities (allergies, fear, liability) of non-certified dogs
- Misuse/abuse of process (housing, schools, workplaces, eateries)
  - Easy process to classify an ESA (therapists or online ESA mills)
  - Service vests- what is and isn't correct?
- Confusion
   – human rights violations/discrimination/mental health?
  - A "no pets" clause could amount to discrimination
  - Landlords and stratas have a duty to accommodate a tenant's disability. The duty to accommodate <u>may</u> include allowing you to live with an emotional support animal.
  - How does it create undue hardship?
