Cowichan Carbon Busters want to respond to a recent staff report to the EAC, requested by Council in 2023, concerning the benefits of accelerating the solar program within the Climate Action and Energy Plan. We believe that staff and consultant recommendations are not a sufficient response to the ongoing world-wide climate crisis. Our concerns include: factual and conceptual errors within the report, lack of consideration for the non-business case of solar energy, and a general lack of appreciation of the benefits of solar energy to the community in both adapting to climate change and forestalling its worst impacts.

We want to support staff and Council rather than just be critics. So we will ask for no significant funding; rather, we will offer our own financial and volunteer assistance to motivate the public to install more solar energy systems in our community as meaningful action on climate change.
