6.1.1 Cowichan Climate Hub

Jane Kilthei and Valerie Russell of Cowichan Climate Hub presented to Council regarding keeping the current Zero Carbon Step Code Building bylaw in place.

8. STATUTORY HEARING MATTER

8.1 Statutory Right to be Heard

8.1.1 Explanation of the hearing process

Mayor Douglas called the statutory hearing to order at 6:40 p.m. and provided an explanation of the statutory hearing process.

8.1.2 Development Variance Permit for 7136 Richards Trail

- 1. The Corporate Officer introduced Development Variance Permit Application DVP00116.
- 2. The Mayor provided the applicant with an opportunity to provide details of their application. No comments were presented.
- 3. The Corporate Officer advised that one piece of correspondence was received from Farmer Ben's Eggs listing their concerns about the importance of preserving agricultural land in North Cowichan.
- 4. The Mayor provided an opportunity for comments from persons affected by the proposed permit. No one commented.
- 5. No new information was provided in relation to the proposed permit.

IT WAS MOVED AND SECONDED:

THAT Council authorizes the issuance of Development Variance Permit No. DVP00116 and grant a variance to Section 51(2) of "Zoning Bylaw 1997, No. 2950" by decreasing the minimum lot size on 7136 Richards Trail from 12 hectares to 5.8 hectares. CARRIED

9.1 Reserve Fund Establishment Bylaw No. 4019, 2025 for adoption

10.1 Development Permit with Variance at 2557 Alexander Street (Application DP000330)

IT WAS MOVED AND SECONDED:

THAT Council approves the Development Permit DP000330 at 2557 Alexander Street (PID 032-365-799) to construct a 46-unit 4-storey apartment building as attached to this report dated June 4, 2025, including variances to Zoning Bylaw 1997, No. 2950, to:

- 1. Permit one parking stall in the front yard of the R8 Zone at 2557 Alexander Street under Section 18(2)(c);
- Decrease off-street parking requirements from 1 stall per residential unit (46) plus 15% of the number of units as visitor parking (7) for a total of 53 stalls to 0.96 stalls per unit (44) plus 2% visitor parking (1) for a total of 45 stalls under Section 21(7);
- 3. Increase the principal building height from 11.0m to 15.5m under Section 63(7)(a); and,

4. Decrease the two-way drive aisle width from 7.6 m to 6.0 m under Section 24(1).

10.2 Chemainus Community Garden

IT WAS MOVED AND SECONDED:

THAT Council approves a 1-year licence of use agreement with CowichanNeighbourhood House Association for the partial use of 9800 Willow Street inChemainus for a food garden.

10.3 Noise Bylaw Exemption: Catalyst (Crofton Mill)

IT WAS MOVED AND SECONDED:

THAT Council directs the Chief Administrative Officer, or their delegate, to use their discretion when directing bylaw compliance officers to enforce noise infractions under Noise Bylaw No. 2857 as they pertain to Domtar Inc. (Crofton Mill) to allow all activity related to the repair of the Crofton Mill waterline from Wednesday, June 11 to Tuesday, June 17, 2025. CARRIED

11. NEW BUSINESS

11.1 Amendment to Building Bylaw [Zero Carbon Step Code]

THAT Council, in accordance with section 4.4.4 of the Notice of Motion Policy, refers the 'Amendment to Building Bylaw [Zero Carbon Step Code]' notice of motion to staff to return with a report outlining the policy implications including the Climate Action and Energy Plan objectives; recent costing studies; as well as information on the energy level that is being achieved in recent building permits issued both prior to and after adoption of EL-4 step code, to assess the local building industry's readiness with the new standard. CARRIED

11.2 Changes to Municipal Director Appointments to the CVRD – Councillor Manhas

THAT Council Postpone consideration of the motion to change the Municipal Director Appointments to the Cowichan Valley Regional District (CVRD) Board until after the review of the strategic planning session is complete, and to make the appointments to the CVRD as quick as possible afterwards. (Opposed: Caljouw, Findlay, Hogg, Manhas) DEFEATED

IT WAS MOVED AND SECONDED: THAT the following motion:

THAT Council appoints Councillor's Findlay and Manhas as Municipal Directors to the Cowichan Valley Regional District Board, with Councillor Justice as Alternate Director #1, and Councillor Istace as Alternate Director #2

be amended to remove the words "Findlay and" and to remove the word "Justice" and replace with "Findlay" as Alternate Director #1.

IT WAS MOVED AND SECONDED:

THAT Council appoints Councillor Manhas as Municipal Director to the Cowichan Valley Regional District Board, replacing Councillor Istace, and appoints Councillor Findlay as Alternate Director #1, Councillor Istace as Alternate Director #2, and Councillor Hogg as Alternate Director #3.
