## NCD RCMP Service to the community Jan – Mar 2025:

 In January your detachment celebrated the unveiling of the ceremonial totem outside the building and the etched glass work in the lobby. A number of dignitaries were present to witness the celebration and Chief Daniels and the Tzinquaw Dancers made the occasion a special one with a presentation and ceremonial dancing to showcase the talent of both local artists.



- 2. In January, your members were advised what appeared to be a femur, vertebrae and ribs were located at the end of the Crofton boat launch dock. This information had been forwarded by a marine biologist from Washington State after they noticed a member from their marine enthusiast group had posted photos of the bones on their website. Members attended the dock area and located the place where the bones were seen. Members engaged the RCMP Underwater Recovery Team who conducted a dive and retrieved the bones. The Coroner's Service and a Bone Identification Specialist determined they were animal bones.
- 3. In January after a drug surveillance project had been conducted on a low to mid level female drug trafficker in the corridor, your Street Crimes members executed two search warrants on the dealer's home and vehicle. The project was funded by the SITE initiative. As part of the investigation, your members seized \$18,000 in meth, cocaine, fentanyl, mushrooms...etc. An additional \$1000 in cash was seized and a replica handgun. The suspect was arrested and the members are engaging with the Civil Forfeiture office to apply to have the suspect's proceeds of crime seized and disposed.

- 4. In February the detachment were notified of a kidnapping incident near Queen's Street in Duncan. Video footage obtained showed two males with a weapon assaulting a third male in a back alley and then forcing the victim into a vehicle. The vehicle was later located by members on Lewis Street in North Cowichan. The primary suspect was arrested without incident and was charged with 4 offences including Kidnapping, Assault with a Weapon, Assault and Possession of Weapon for a Dangerous Purpose. The victim was located safe. The second suspect was located a few days later and charged with the same offences. Search warrants were executed on the suspect vehicle revealing drugs weapons and cash. Trial date to be set.
- 5. In February, detachment members were dispatched to a report of someone using a blue laser to illuminate the wing of a flight coming into the Victoria International Airport. Laser beam originated from the north side of Maple Bay Rd. Despite seeking help from the public, members were unable to locate the source of the beam.
- 6. In early February members were dispatched to locate a missing male from Duncan. The male was suffering mental health concerns and was actively avoiding the police and anyone looking for him. Significant resources were dispatched in order to locate before the male hurt themselves or others. Banking and cell phone searches conducted with negative results. Eventually the male was located by an observant NCD member checking a male who was wearing a hood and ski mask. The male was returned to their care provider.
- 7. In February the owner of a business on Canada Ave was assaulted outside of their store by two unhoused individuals from the community. The two suspects had stolen items from the store and the owner attempted to get the items back, when they were assaulted by the two people. Member attended and obtained descriptions of the two who were located in a tent the next morning. Both arrested. One suspect was released from custody by the court. The other suspect was held, released and rearrested after they were located violating their release conditions.
- 8. In March a community member went missing with the possibility they had fallen in the Cowichan River. The detachment engaged with Cowichan Search and rescue, Cowichan Tribes Emergency Management, Westcoast Marine, PDS and Air Services to search the river and estuary area. Significant resources were dedicated to trying to locate the missing male. To date, all investigation and search efforts have yielded negative results, however in late May, human remains have been located in the River. Your detachment will be utilizing DNA testing to identify if there is a connection to the missing community member.
- **9.** In March members attended for a report of a male being viewed on CCTV attempting a B&E at a local business. The male also attempted to light the side of the building on fire. Numerous members responded, located the male hiding nearby and arrested him. Numerous charges were approved by the Crown. Court date to be set.
- 10. In March members were called to a report of a theft on Station Street. Members attended and located community members holding down the suspect after the male had stolen the victim's purse. EHS attended to assist the lady with her injuries (she later required surgery for a

fracture associated to the incident). A statement was obtained from the suspect who admitted what they had done. Crown approved a charge of robbery (and subsequent offence related to the injuries) against the suspect. The male has pled guilty to the offences and remains in custody pending sentencing.

11. Detachment members (Cst Callum Crossley and Cst Dave Madill – NCD Community Safety Unit) attended the Cowichan Chamber of Commerce Black Tie event to assist with the recognition of dedication and hard work done by 25 local community members. Pictured below is the 2025 Lifetime Achiever award recipient, Fatima Da Silva.



- 12. In March detachment members met with community members at a Town Hall meeting to discuss concerns from the public. The outcome of the consultative meeting is being used to document the proactive policing work your detachment will work on for the next 12 months. This was an opportunity to hear from the public in a open forum, so the detachment understands what issues are important to the community and take steps to help address those concerns. Requests ranged from the need for more attention being given to road safety initiatives, to, increased police presence in the corridor area of the community. These requests have been added to the Annual Performance Plan for your detachment.
- 13. Your members have responded to several calls in which people have been seen in the Valley in possession of what appear to be hand guns. These calls for service are extremely serious. Members assess each situation based on the unique factors involved in each scenario. Their commitment is to public safety so any decision they make, takes in account all aspects they face in order to de-escalate risk to all involved. The photo attached shows the degree to which items like the "lighter made to look like a gun" can result in tragic outcomes.



**14.** In March your members responded to a report of a hostage taking in the community. Incident involved an allegation that a community member owed another person "drug money". Using

electronic triangulation and emergency communications warrants, members were able to learn the time and date of the "meet" to exchange money/victim. Detachment members surveilled the location and when the exchange took place, your members quickly arrested the main suspect and accomplices. The investigators are completing the disclosure stage and the suspect remains in custody. The successful outcome in this investigation involved your detachment GIS investigators, IPS members, Community Safety Unit investigators and Vancouver Island Police Dog Services.

- **15.** In March members responded to a serious motor vehicle incident involving a 25 yo male from the community. The male had been crossing the TCH north of Beverly when they were struck by a loaded tractor trailer unit. The male was transported by ground ambulance to VGH and remained in hospital recovering from their injuries. Investigation determined the driver of the tractor trailer unit was not at fault for the outcome.
- 16. In March members attended the scene of a fatal MVI at the intersection of Boys Road and TCH. Members located two trucks involved with one vehicle on it's roof, with two occupants trapped inside. Fire and EHS on scene at the same time and attended the injured. The northbound lanes of TCH were closed off for a period of time. The passenger of the truck on it's roof could not be revived. Speed was deemed a factor.

Enclosed on page 7 is the outcome (final results) of the 2024-2025 Annual Performance Plan (APP) for your detachment. As mentioned above, the APP is a plan the detachment follows each year to action items the community and community leadership would like to see members working on, in order to enhance safety and security for citizens in the Valley. Overall your detachment did well against targets set last year. However, we came up short in our Restorative Justice referrals and didn't make our target of 2000 road safety initiatives planned. Both these goals are included in the new APP for this year with expectations to meet and exceed the new targets set out.
