**Municipal Fine and Fees and Charges Amendment Bylaw**

BYLAW NO. 4051

---

*A bylaw to amend Bylaw Offence Notice Enforcement Amendment Bylaw No. 3677, 2021, Municipal Ticket Information System Bylaw No. 3464, and Fees and Charges No. 3784, 2020, to include fine and fee updates related to the recently amended Fire Protection Bylaw.*

---

The Council of The Corporation of The District of North Cowichan, enacts in open meeting assembled, as follows:

**Citation**

- 1 This Bylaw may be cited as "*Municipal Fine and Fees and Charges Amendment Bylaw No. 4051, 2026*".

**Amendment**

- 2 Bylaw Offence Notice Enforcement Bylaw No. 3677 is hereby amended as follows:
  - (a) By deleting item 4(7) listed under the [Bylaw Enforcement Officers] heading and replacing it with the following:

"(7) Exempt Chief Fire Officers"
- 3 Municipal Ticket Information System Bylaw No. 3464, 2013 is hereby amended as follows:
  - (a) By making the following changes to Schedule A – Schedule 1:
    - (i) By adding "Exempt Chief Fire Officers" to item 5, under column 2.
    - (ii) By adding "Deputy Fire Chief" to items 7, 8, 9, 10, 13 and 14, under column 2.
    - (iii) By deleting "Local Assistant to the Fire Commissioner" from items 7 and 8, under column 2.
    - (iv) By adding "Fire Chief" and "Assistant Fire Chief" to item 9, under column 2.
- 4 Fees and Charges No. 3784, 2020 is hereby amended as follows:
  - (a) By making the following changes to Schedule "A" Administration Fees (*Section 1, General Administrative Fees*):
    - (i) By deleting "No Charge" from item 32. Fire Safety Plan Review, column 2, and adding "\$150.
    - (ii) By deleting "No Charge" from item 34 Special Fire Inspection, column 2, and adding "\$100"

(iii) By deleting "No Charge" from item 36 Fire Inspection Report (re-inspection), column 2, and adding "\$100"

(b) By deleting Schedule "G" – Protective Services Fees (*Section 1, Fire Equipment Fees*) and inserting the following in its place:

**SCHEDULE G - PROTECTIVE SERVICES FEES**

10	Rescue Vehicle – Standby	\$225 per hour
11	Tanker Truck – Active Service	\$450 per hour
12	Tanker Truck – Standby	\$225 per hour

(c) By deleting "Manager of Fire and Bylaw Services" from Schedule H – Nuisance Abatement Fees, Section 1 – District Employees, and replacing it with "Manager, Bylaw and Business Licensing Services, and Exempt Chief Officers"
