

#### **REQUEST**


Provide a Jan to Mar 2022 review summary of the Downtown Duncan Corridor and Area. Include a map and identify data trends that may be of interest to City Councils and our partners in Bylaw departments.

#### **DEFINITIONS & DATA CAVEATS**

- General Occurrence "GO" data was used as the primary data set as opposed to Calls for Service
  "CFS" data. A small portion on CFS is included in this report to identify root drivers for a specific
  UCR code.
- To assist a reader from outside policing with this report please understand that a call for service is translated into a general occurrence which has a UCR (Uniform Crime Report) code. In this report these codes have been grouped 'UCR Groups' which are further grouped into 'UCR Types'.
- For example UCR <u>code</u> (Break & Enter Business) is grouped into UCR <u>Group</u> (Break & Enters) which is grouped into UCR <u>Type</u> (Property Crime). Some UCR <u>groups</u> may appear to have the same name (e.g. 'sex offences' and 'weapons offences') under different offence <u>types</u>. This is because some offences in these groups have victims (i.e. are violent crime types), while others do not. These groupings are made and named by E Div RCMP based on best practices on UCR reporting as mandated by Statistics Canada.
- A 'most serious offence method' was used so each incident only has one offence code/group/type
  reflecting the most serious thing that occurred in the incident. This is consistent with reporting
  standards as reported by Statistics Canada.
- Founded events only were included. Events deemed to be *unfounded*, *assistance*, *for information or preventative* were not included. It is for this reason mental health files were excluded from the report as they are deemed 'assistance' in nature and this is reported on separately in the quarterly report to mayors and council.
- Area definitions: The area examined (Downtown Duncan Corridor and Area) is defined by the
  BLACK polygon on the map on page 2. For the purposes of this report, it is referred to as the
  'Downtown Corridor and Area'. Anything that occurred outside the bounds of the black polygon
  is beyond the scope of this report.
- Within this area, 4 additional sub-areas are defined for the purposes of this report by the **RED** polygons on the map (page 2) where they are also named.
- Data was extracted on Apr 1, 2022 from Versadex and is presented as found at that time.



# Downtown Corridor & Area - ByLaw Offences Jan - Mar, 2022



#### **EXECUTIVE SUMMARY**

- Overall Police were called to the Downtown area 1% less in the first 3 months of 2022 than 2021.
- Top UCR codes:
  - The top 3 UCR codes were Unspecified Assistance, Suspicious Activity, and Check Welling which made up 33% of all the occurrences to the area. Of these 3 UCR codes only Unspecified Assistance increased (+26%).
- While overall the file count decreased 1%, changes did not occur uniformly across UCR Types:
  - Criminal Code events (Violent Crime + Property Crime + Other Criminal Code Occurrences) increased 12% (+67 incidents).
  - o **Violent crime** fell 18% (-23 incidents). Within the Violent Crime Type:
    - Assaults fell 17% (-13 incidents)
    - Utter threats fell 39% (-12 incidents).
  - Property Crime increased 20% (+57 incidents). The increase was accounted for almost exclusively by:
    - Mischief to Property (group) was up 36% (+44 incidents). Within Mischief to Property UCR code: Mischief – Loss of Enjoyment of Property accounted for the majority of the increase, itself increasing 37 incidents.
      - In looking at CFS data 'Unwanted Person' also increased +26% (92 incidents).
    - Shopliftings increased 17% (+9 incidents). Shoplifting activity has been very closely tied to COVID-19 restrictions, and is still well below pre-COVID numbers.
  - Other Criminal Code Offences increased 27% (+33 incidents). Primary drivers were increases in:
    - Breach of Conditions up 19 incidents (+68%).
    - Cause a disturbance up 17 incidents (23%).
  - Other Offences (non criminal) were only up 1%. Significant increases in this category were:
    - Unspecified Assistance up 69 incidents (+26%)
      - In looking at CFS data 'Unwanted Person' also increased +26% (92 incidents).
    - False Alarms up 21 incidents (+38%).
    - There was not significantly more Bylaw offences calls to police in the first QTR of 2022, when compared to 2021 for the area overall.
  - CDSA (Drug) Offences (-59%), Provincial Statue Offences (-9%) and Traffic Offences (-39%) all decreased. The changes in the police reported incidents of theses offence types may be more indicative of a change in police behaviour (such as decreased proactive policing time to detect these offences), rather than an actual decrease in the frequency of these offence types.
- Four sub areas are identified as micro-areas of activity or are of recurring interest to our community and various stakeholders. See page 3 for area definitions.
  - Warmland & Area (Increase in volume of 47%);
  - Trans Canada Hwy (TCH) Corridor (Increase in volume 16%);
  - Duncan Mall/Village Green mall and area (Increase in volume 13%);
  - Downtown Duncan (decrease in volume 9%)

#### **DETAILED FINDINGS**

# GO By UCR Type

Changes in general occurrences in the Downton Corridor and Area varied by type of incident as shown in the table below. Decreases occurred for Violent crime (-18%), CDSA Offences (-59%), Provincial Statue (-9%) and Traffic Offences (-39%). While Property Crime (+20%) and Other Criminal Code Offences (+27%) both increased. Changes in some Types such as CDSA and Traffic offences may be indicative of decreased proactive policing time being used to target these offences rather than an actual change in the real incidence of these types. Total Criminal Code incidents\* rose by 67, or 12% for the QTR.

\*CRIME = PERSONS VIOLENT CRIME + PROPERTY CRIME + OTHER CRIMINAL CODE OFFENCES.

# Most Frequent UCR codes

The table below shows top 20 UCR codes by frequency. UCR codes are the codes that are grouped and typed above. These 20 UCR codes make up 80% of the total occurrences to the area. Increases in 'Unspecified Assistance', 'Bylaw-Other', 'Cause A Disturbance', 'Mischief – Loss of Enjoyment of Property' and 'False Alarms' were drivers for increases overall to the area. Combined theses files increased by 167 incidents or 32%. Unspecified Assistance UCR was up 26% from 2021 and 184% when compared to 2020 (data not shown in table for 2020).

#### GOs By Location Type

Over half of all files (55%) occurred specifically outside (streets, parking lots, and open areas/parks) in 2021. This is unchanged from the previous corridor report. Note: this likely undercounts the volume of files actually occurring outside as almost every other location type could also actually be occurring in outside spaces around the locations. However PRIME currently lacks the detail to quantify this. There continues to be a concentration of activity occurring outdoors on the streets, parking lots and open areas.

# **General Occurrence Location Types sorted by Frequency:**

Files changed disproportionately by location type. Change in location type by volume is shown in the table below. For simplicity values <10 were excluded. Noteworthy increases are highlighted in red. Parking lots, other commercial/corporate places, homeless shelter, banks and schools during not supervised activity all had the largest increases.

#### Calls for Service

Calls for service (CFS) data can indicate the nature of the initial complaint. This can be valuable when looking at UCR codes such as 'unspecified assistance', which is by definition not specific. The difference between call data and General Occurrence (GO) data is beyond the scope of this report, but the reader should note CFS types do not always translate into the same General Occurrence UCR code. For example while there is an UNWANTED PERSON call type, no such category exists in UCR offence codes. Also while a call may be an ASSAULT in progress, the circumstances of the incident may not always mean the UCR offence code is ASSAULT. This is not an inaccuracy, just a reality of the data. Top 10 CFS types in Q1 2022 are displayed below. These ten call types make up 55% of all the CFS to the area.

#### Micro-Areas

Within the corridor & area there are 4 sub-areas that have some clustering of occurrences (see page 3). Approximately 70% of all incidents in Q1 2022 occurred within one of the following sub-areas. The TCH corridor, Warmland Area and Duncan Mall all had a significant increase in GOs, while Downtown Duncan had a slight decrease in volume of GOs.

#### TCH Corridor

25% of all the occurrences in the downtown area occurred in the 'TCH corridor' (see map on pg 3). GOs increased 16% in this area when compared to last year. UCR codes *Unspecified assistance, Bylaw – Other, False Alarms and Disturbances*s increased disproportionately in this area. Combined Bylaw files (noise, other and litter) increased 39% to this area (compared to 9% overall).

# Duncan Mall/Village Green Mall & Area

20% off all GOs to the Downtown Area occurred in the Duncan Mall/Village Green Mall & Area. Overall GOs to this area increased 13% for the QTR. UCR codes *Unspecified assistance, Shoplifting, Disturbances* and *Check Wellbeing* files increased significantly in this area. Combined Bylaw files (noise, other and litter) remained unchanged for the QTR when compared to 2021 for this area.

#### Warmland & Area

The new OPS site moved to this area in November 2021. This area makes up 19% of all the GOs to the Downtown area. The Warmland area saw the largest increase in volume of GOs, increasing 47% (compared to 1% to the Downtown area overall). There was significant growth in GOs overall and specifically 9 out out the top 10 GOs in this area. Combined *Bylaw files* (*Noise, Litter, Other*) – increased from 15 to 33 (120%) in this area.

#### Downtown Duncan

This area makes up just 6% of the area total for Q1 2022 (by volume of occurrences). There was no significant change in any of the top 10 categories, mostly due to low numbers which can skew % changes.

#### Conclusion:

Police attended occurrences in Q1 of 2022 in the downtown and area of Duncan showed some variability in frequency. Consistent with previous reports, the single greatest complaint was 'Unwanted Person' which made up 21% of all the CFS to the area.

Crime increased 12% overall. Increases in volume were attributable to increases in Mischief – Loss of Enjoyment of Property and Shoplifting. Mischief – loss of enjoyment of property was driven up by a 26% increase in Unwanted Persons calls. With respect to shoplifting the increase reflects a 'trending toward normal' after very low shoplifting numbers in recent years due to COVID related restrictions and financial benefits. While Crime increased overall in volume it became less serious, with violent crime decreasing 18%.

There was a significant growth in volume of activity in the Warmland Area which increased 47% (by volume). It is noteworthy that the Overdose Prevention Site (OPS) moved to this area in November 2021. The TCH corridor and Duncan Mall/Village Green Mall increased more modestly in volume (16% and 13%), while Downtown Duncan decreased 9%. The Warmland Area and TCH saw significant increases in police attended ByLaw related issues.

In terms of location type – 'Schools during not supervised activity' (i.e. school property, after school hours), had the single greatest increase in volume (by percent). Most of the schools in the Downtown Corridor and Area fall in the Warmland Area polygon. Activity in parking lots also increased significantly.
