Mayor Siebring outlined the public hearing process and called the public hearing to order at 6:00 p.m. for Zoning Bylaw Amendment Bylaw (6478, 6494, 6493, 6489 from R1 & 6495 Paddle Road from CD10 to CD22), 2022, No. 3867.

The Corporate Officer, Michelle Martineau, noted there was one submission received after the agenda was published with concerns of the zoning amendment and read out the correspondence submitted by Joyce Behnsen.

Council, by unanimous consent, opted not to hear the presentation from the Development Planner, Caroline von Schilling, as they had seen it previously, but did ask questions.

The Corporate Officer, Michelle Martineau, noted that no written submissions were received from the public.

The proponent provided a presentation that outlined details of the project vision.

The Mayor called for submissions from members of the public a first time, Joyce Behnsen provided the following comments about the development; citing that traffic problems in the area is a priority, and that the planning needs to consider the impacts of the danger that increased traffic will bring to that particular hub.

The Mayor called for submissions from members of the public for a second and third time and no one raised their hand to speak.
